**§ 1 Honorar/Engagement**

Delivery shall take place via electronic channels (email/cloud file transfer) until 31 Dec 2022. This delivery constitutes the whole obligation of the Photographer towards the Model.

The Model shall not receive any further payment nor is entitled to any profits from the sale of the photographic or video materials or their copies in any state, including NFT-certified reproductions, or the sale of licenses and copy rights or any resulting royalties.

**§ 2 Photographer's rights**

The Model hereby grants the Photographer the irrevocable, perpetual and unrestricted right to use the images and other materials including her likeness taken at the Shoot and any other reproductions or adaptations thereof, either complete or in part alone, including, but not limited to: self-promotion of Photographer's business, portfolios, exhibitions, contest and social media sites, as well as for any commercial purpose not involving the selling or transferring of publication rights without the Model's prior written consent.

The Photographer is not allowed to sell or transfer the publications rights of the photographs and other materials produced at the Shoot without the Model's prior written consent.

The Photographer agrees that altering photographs and any other materials produced at the Shoot in such a manner as to discredit or misrepresent the Model's public image in any way is prohibited to the extent provided by the applicable law.

**§ 3 Model's rights**

The Photographer hereby grants the Model the irrevocable, perpetual and unrestricted right to use the processed photographs, including: self-promotion of Model's business, portfolios, exhibitions, contest and social media sites.

The Model is not allowed to sell or transfer the publications rights of the photographs without the Photographer's prior written consent.

**§ 4 Further agreements**

No changes to the terms of this model release are accepted unless agreed in writing by the Photographer and the Model.

The processed photographs and any other materials produced at the Shoot will be provided to the Model in digital format optimized for web publication and/or, at the Photographer's discretion, in digital format optimized for print publication.

Model hereby affirms that he/she is over 18 years old and is fully able to contract in his/her own name without breach of any prior agreement or applicable law.
